## U.S. Department of Transportation **SAFE STREETS and ROADS FOR ALL (SS4A)**

**Application Deadline: July 10, 2023, 5:00 pm ET**

**PROGRAM DESCRIPTION:** ...The purpose of SS4A grants is to improve roadway safety by significantly reducing or eliminating roadway fatalities and serious injuries through safety action plan development and refinement and implementation focused on all users, including pedestrians, bicyclists, public transportation users, motorists, personal conveyance and micromobility users, and commercial vehicle operators. The program provides funding to develop the tools to help strengthen a community's approach to roadway safety and save lives and is designed to meet the needs of diverse local, Tribal, and regional communities that differ dramatically in size, location, and experience administering Federal funding...

**COST SHARE: 20% Match**

## **Tribal Broadband Connectivity Program (TBCP)**

The Infrastructure Investments and Jobs Act appropriated an additional **\$2 billion to TBCP**, an NTIA program previously implemented under the Consolidated Appropriations Act, 2021. The TBCP directs funding to tribal governments to be used for the following initiatives:

- Broadband Deployment on Tribal Lands
- Telehealth
- Distance Learning
- Broadband Affordability
- Digital Inclusion

## **American Rescue Plan Act (ARPA) OF 2021**

The American Rescue Plan Act (ARPA) of 2021 is latest relief package for COVID-19 which provides \$1.9 trillion in mandatory funding, program changes, and tax policies aimed at mitigating the continuing effects of the pandemic. The U.S. Department of Treasury has published the Interim Final Rule (Guidance) and State and Local Aid Allocations.

### **Period of Performance**

The State, Local, and Tribal Aid Funds being administered by the U.S. Department of Treasury provides the following important dates:

All funds **must be obligated by:**

**December 31, 2024**

All funds **must be expended by:**

**December 31, 2026**
