Cost Share: 25 percent local cash match (cost share) is required unless a waiver is approved.

Anticipated Grants

Eligible Applicants:

The following entities are eligible to apply under this program:

- States, units of local government, Indian tribes, and their public agencies, including:
 - school districts, including public charter schools and school districts with a single school;
 - school boards;
 - law enforcement agencies.

Eligible Equipment: Please see the [FY25 SVPP Application Resource Guide](#) (Pages 2-8) for a non-exhaustive list of allowable and unallowable costs.

- Entry Control Equipment
- Door locking mechanisms/access control doors
- Peepholes for classroom doors
- School site alarm and protection systems—Motion detectors
- Lighting (on school grounds)
- Communication technology
- Emergency call boxes
- Intercom or public address (PA) system
- Panic and immediate alarm notification systems
- Two-way radios
- Emergency alerts—Automated text messages or email
- Identification technology—ID scanning devices (and accompanying equipment)

FY25 SAFER STREETS AND ROADS FOR ALL



Funds for the fiscal year (FY) 2025 SS4A grant program are to be awarded on a competitive basis to support planning, infrastructure, and behavioral and operational initiatives to prevent fatalities and serious injuries on roads and streets involving all roadway users, including pedestrians, bicyclists, public transportation, motorists, and commercial vehicle operators.

Application Deadline: June 26, 2025 at 5:00 PM ET

Eligible Applicants:

- Metropolitan planning organizations;
- Political subdivisions of a State or territory (e.g., cities, towns, counties);
- Federally recognized Tribal governments; and
- A multijurisdictional group of entities described in any of the aforementioned three types of entities.

Available Funding:

This Notice makes available up to \$982,260,494 for FY 2025 grants:

- **\$580,000,000** is available for Implementation Grants
 - Expected number of awards: 40 to 70
 - **Expected funding range: \$2,500,000 to \$25,000,000**
- **\$402,260,494** is available for Planning and Demonstration Grants
 - Expected number of awards: 400 to 700
 - **Expected funding range: \$100,000 to \$5,000,000**

The Department reserves the right to make more, or fewer, awards. USDOT reserves the discretion to alter minimum and maximum award sizes upon receiving the full pool of applications and assessing the needs of the program in relation to the SS4A grant priorities in Section D.3. DOT may increase the overall amount of funding if additional funds become available.

Cost Sharing or Matching Requirement:

Recipients are required to contribute a local matching share of no less than 20 percent of total eligible project costs.
